<p><a href="#">HB 2</a></p>	<p>HB 2 is the state budget policy bill. The full Senate voted to add the language from <a href="#">HB 625</a> to the state budget. HB 625 bans abortion at 24 weeks gestation with almost no exceptions. Requires mandatory ultrasounds prior to all abortion care, regardless of stage of pregnancy. The Senate added the language to the state budget, HB 2, which was then signed by the governor and took effect January 1, 2022.</p> <p>State senators introduced four amendments to HB 2 to mitigate the harm of the abortion ban. All four amendments failed in identical 9-14 votes.</p> <ul style="list-style-type: none"> <li>• Amendment <a href="#">#2021-1874s</a>, remove abortion ban from state budget</li> <li>• Amendment <a href="#">#2021-1876s</a>, add fatal fetal diagnoses as exception to abortion ban</li> <li>• Amendment <a href="#">#2021-1883s</a>, add rape and incest as exceptions to abortion ban</li> <li>• Amendment <a href="#">#2021-1878s</a>, remove ultrasound requirement from state budget, remove criminal penalties for providers</li> </ul> <p>Finally, state senators introduced <a href="#">an amendment</a> to HB 2 that would codify the tenets of <i>Roe v. Wade</i> into state law – protecting abortion rights for Granite Staters prior to 24 weeks. This amendment failed in a 9-14 vote.</p>
<p><a href="#">SB 399</a></p>	<p>Adds an exception for fatal fetal diagnosis to the newly-enacted abortion ban and removes the mandatory ultrasound requirement. This vote failed 11-13 in the Senate.</p>
<p><a href="#">SB 436</a></p>	<p>Adds protections for abortion access into state statute, codifying the tenets of <i>Roe v. Wade</i> into New Hampshire law. This bill failed 12-12 in the Senate.</p>
<p><a href="#">HB 1609</a></p>	<p>As amended by the House, adds one exception (fatal fetal diagnoses) to the newly-enacted abortion ban and removes the mandatory ultrasound requirement. This amended bill passed the full House and full Senate and was signed into law by the governor.</p>
<p><a href="#">HB 1080</a></p>	<p>Allows employees at a pharmacy to deny contraception, including condoms, to individuals based on personal beliefs. This bill passed the full House and was referred to Interim Study by the Senate.</p>
<p><a href="#">HB 1625</a></p>	<p>Removes New Hampshire’s patient safety zone law, which allows, but does not require, reproductive health centers to enact a zone up to 25 feet for patients and providers to safely enter and exit the center. This bill passed the full House and full Senate and was vetoed by the governor.</p>
