CCCA LTE:

Dear Editor,

New York State must safeguard affordable access to birth control by enacting the Comprehensive Contraception Coverage Act (CCCA) – a simple, commonsense measure building on the Affordable Care Act’s requirement that health insurance coverage includes contraception.

The CCCA helps connect New Yorkers to the FDA-approved contraception that’s right for them whether for planning a pregnancy or other prescribed needs, regardless of gender, increases consistent use with 12-month dispensing, and includes coverage for the emergency contraception already available in pharmacies.

Contraceptives require consistent use for roughly three decades. The CCCA helps ensure the affordability and constancy needed to reach that goal. In 2013, it was estimated that the ACA saved over a billion dollars that would have been spent on co-pays. Research also shows that having a year’s supply of contraception on hand reduces a woman’s odds of an unintended pregnancy by 30% - a vital step in a state like New York, with one of the highest rates of unintended pregnancy in the country.

Federal attempts to curtail our access to reproductive health care show no signs of stopping. The Assembly has passed the CCCA; now it’s time for the Senate to vote for our reproductive health care.
