If elected, what will you do to interrupt the use of the criminal justice system to deport people charged with minor offenses?

Some immigrant people in detention and incarcerated people have even been forced to give birth while shackled. What will you do to ensure that immigrant and incarcerated people have proper reproductive care and do not deliver in shackles?
