Take Action

Reproductive rights, health, and freedom are not up for negotiation – Together, we will make sure that elected officials are held accountable.

- *HB 500 is a dangerous attempt by politicians to interfere with the privacy and health care of Montanans.*

Every person's circumstance is different and every pregnancy is unique.

We all deserve access to health care based on our medical needs and doctor's best judgment.

Throughout their pregnancy, a person must be able to make health decisions that are best for their circumstances, including whether to end a pregnancy, without interference from politicians and the government.

- *On Saturday, March 16th, the House Human Services Committee will hear HB 425, which would lift the Medicaid Expansion sunset, and protect the health care of nearly 1 in 10 Montanans.*

Planned Parenthood Advocates of Montana supports HB 425.

Some legislators are calling for changes to Medicaid that would kick up to 43,000 Montanans off their health insurance, according to a recent study.

We are asking supporters to contact their legislators to oppose LC 1251 and any proposal that would impose eligibility restrictions, like work requirements. Work requirements that would disproportionately affect women, families, and low-wage workers.

Join PPAMT in Helena on March 16 for the bill's 9AM hearing in House Human Services, as well as a rally to protect Medicaid in Montana.

- *Rep. DeVries' (R-Jefferson City) "personhood" bill HB 302 has passed out of the House and moved to Senate Judiciary Committee for consideration. This legislation is an extreme overreach by government into the private lives of Montanans and its far reaching effects would impact abortion rights, contraception methods, and even in vitro fertilization.*

Call (406) 444-4800 and leave a message telling your senator to vote No on this bill and to protect Montanans' right to access safe, legal abortion.

Although these bills did not pass, thank you for the calls that you made and the messages you wrote in support:

- [*HB 465: Generally revise the Montana human rights act*](#)

Carried by Rep. Kim Abbott (D-East Helena), HB 465 advocated for adding "sexual orientation, gender identity, and gender expression" to the existing Montana Human Rights Act, protecting LGBTQ+ Montanans from the threat of being fired or denied housing due to their identities. House Judiciary Committee tabled this bill once again this year, meaning that it is effectively dead. As we have in the past, PPAMT will continue the fight for dignity for all Montanans.

- [*HB 595: Require coverage of 12-month supply of prescription contraceptives*](#)

Introduced by Rep. Laurie Bishop (D-Livingston), HB 595 would have ensured Montanans better access to birth control and the benefits that result from consistent use, such as reducing a user's odds of unintended pregnancy by 30%. Unfortunately this bill was tabled in House Human Services Committee this week. PPAMT understands the importance of all Montanans having reasonable access to birth control and you can trust that we'll introduce this bill again during the next legislative session.

Bills to Support

- [HB 425: Generally revise medicaid expansion laws](#)

Requested by Rep. Mary Caffero (D-Helena), this bill will serve as the House Democrats' vehicle for preserving Medicaid coverage for nearly 100,000 Montanans. Join PPAMT in Helena on March 16 at 9am for the bill's hearing in House Human Services followed by the [rally to protect Medicaid Expansion in Montana](#).

Attacks on Choice

- [*SB 100: Requiring the provision of information before the performance of an abortion*](#)

Requested by Sen. Keith Regier (R-Kalispell), this bill would require that patients be given the option to look at sonogram footage and listen to the fetal heartbeat before their abortion procedures. There is no exception for patients who are seeking abortion after a traumatic incident, like rape or incest, and a physician would still be required to offer even when they know the patient would not want to see or hear it. This bill has passed out of the Senate and moved to House Judiciary Committee. Make time this week to call House Judiciary Committee members and urge them to vote No on this harmful bill.

- [*HB 302: Constitutional amendment to define person*](#)

Rep. Greg DeVries (R-Jefferson City) is requesting that the Montana constitution be amended so that “person” would apply to all stages of development, including fertilization or conception. As such, the bill would impact access to abortion, various contraception methods, and in vitro fertilization. Because this is amending the state constitution directly, it will require the support of a 2/3 majority of the entire Montana Legislature in order to pass. PPAMT joined our partners with the Montana Reproductive Rights Coalition in opposing this dangerous bill in front of House Judiciary committee. We urge you to call your state senator and tell them to vote No on HB 302!

- [*HB 500: Adopt the Montana Pain-Capable Unborn Child Protection Act*](#)

Introduced by Rep. Lola Sheldon-Galloway (R-Great Falls), this piece of legislation would make it a felony for patients to receive abortions beyond 20 weeks. The bill would even allow for a patient, their spouse, a prosecuting attorney, or the attorney general to sue the physician who performed the procedure. This bill is similar to 2017’s HB 595 from Rep. Derek Skees (R-Kalispell) but worse -- implicating abortions as early as 20 weeks rather than the previous 24 weeks.

- [*LC 584: Referendum requiring the provision of information before performing an abortion*](#)

Another bill requested by Sen. Keith Regier (R-Kalispell), this is an attempt to bypass the Governor’s signature to have Montanans vote to make the above sonogram proposal a law. [Wondering what a referendum is? Check out the January 21 edition of Montana Legislature 101](#)

- *LC 1903: Constitutional amendment to define person*

Also requested by Rep. Derek Skees (R-Kalispell), this is another bill seeking to define “person” within the Montana constitution. Again, because it is a constitutional amendment it will also need the support of 2/3 of the entire Montana legislature to pass.

- *LC 2436: Legislative referendum stating abortion is not constitutional right in Montana*

Rep. Theresa Manzella (R-Hamilton) is proposing that Montana voters decide whether or not Montanans have a constitutional right to make private health care decisions like abortion.
