About the Voter Guide's Score

The Planned Parenthood of Nassau County Action Fund is the political arm of Planned Parenthood of Nassau County and is a not-for-profit 501(C)(4) organization that engages in legislative education and electoral activity, including voter education campaigns, grassroots organizing, and legislative advocacy. The Action Fund encourages public and political support for reproductive health and rights such as: access to birth control. evidence-based sexual health education, emergency contraception access, and access to safe and legal abortion.

The Planned Parenthood of Nassau County Action Fund and the Planned Parenthood of Nassau County Action Fund Political Committee endorses 100% pro-women's health candidates for political office. In this scoring system, 100% indicates complete alignment with Planned Parenthood's public policy positions. "NR" indicates that a candidate did not return a Candidate Questionnaire.

Additional, reliable information sources may occasionally be used, including documented public statements, information on a candidate's website, and endorsements from other groups who support or oppose Planned Parenthood's public policy positions, in the rating and/or endorsement process.
